### 1. For what purposes do we manage your personal data?

## 2. To whom may we transfer Your personal data?

## 3. How do we ensure data security?

#### 6. Links to other domains and social media

#### 7. Use of cookies on the present Website:

Cookies are small files created by the visited website that are placed on the user's computer by the website you are visiting in order to be able to identify the occurrence and time of such visit. #### 8. The present Website uses the Google Analytics application:

The Google Analytics compiles a report based on internal cookies (cookies) regarding the Website user habits, as well as other reports regarding the Website activity. In order to hinder and prevent data abuse or misuse, the data are stored by the Google servers in an encrypted format.
